TUESDAY NINE HOLE TWILIGHT LEAGUE DETAILS

- **20 WEEK SEASON:** 9-Holes * Indian Boundary GC * May 21 thru Oct 1, 2024
- **COOK COUNTY FOREST PRESERVE GOLF CARD** – All players must purchase before registration deadline.
- **PROGRAM FEES.** With the FPG Golf Card (must purchase), the 2024 season will cost:
 - **\$440.00 for adults** - includes 20 green fees, special events, and league gift.
 - **\$375.00 for senior citizens (age 62+)** – includes 20 green fees, special events, league gift.

FULL TIME PLAY ONLY. WILL PROVIDE EACH FOURSOME WITH FOUR PASSES ALLOWING PLAY FOR A FOURSOME EACH WEEK – ANY SUB MUST PURCHASE FOREST PRESERVE GOLF CARD TO PLAY AS A SUB.

- **CARTS:** Gas Cart (\$13.08) or Pull Cart available at course (pay at the course each week you use a cart)
- **TEE TIMES:** Standard 20 fixed tee times from 2:30 p.m. to 4:55 p.m. Tardy groups lose tee time.
- **TERRIFIC TUESDAYS:** Weekly contests such as long drive, closest to pin, or straightest drive contests.
- **SEASON ENDING SALUTE:** Tentatively scheduled for October 1, 2024.
