PLEASE READ CAREFULLY: I desire to participate in the “Ugly Sweater Pub Tour” organized by the Grand Corridor Chamber of Commerce (“GCCC”). I understand that the GCCC may accept my application to participate in the Ugly Sweater Pub Tour only if I agree to be bound by this Release, Waiver and Assumption of Risk Agreement. In consideration of the GCCC accepting my application and allowing me to participate in the Ugly Sweater Pub Tour, I freely and voluntarily agree to this Release, Waiver and Assumption of Risk Agreement. I waive any and all claims that I may now and in the future have against, and release from all liability and agree not to sue the GCCC, its officers, employees, leaders (volunteer or other), agents or representatives (collectively its "staff") for any personal injury, death and property damages, expenses or losses sustained by me as a result of my participation in the Ugly Sweater Pub Tour regardless of cause whatsoever, and including, without limitation, claims of negligence, breach of contract, or any other statutory or common law claim, on the part of or against GCCC or its staff. I am aware that I am responsible for my conduct and actions while participating in the GCCC’s Ugly Sweater Pub Tour and assume all risks associated with the Ugly Sweater Pub Tour, and understand that I may be asked at anytime to withdraw from my participation in the activities should my conduct and actions be deemed inappropriate in the sole discretion of the GCCC staff or staff of an establishment. I shall depart the event at my own expense should this arise. I acknowledge that GCCC promotes and supports responsible drinking and does not endorse in any way drinking and driving or drinking in public. I confirm that I am the over 21 years of age, and that I have read and understand this agreement prior to signing, and freely and voluntarily agree that this agreement will be binding upon me (as a participant), my heirs, next of kin, executors, administrators and successors. The GCCC reserves all rights to alter the scheduled itinerary of events, and I understand registration fees are NOT refundable.
